Letter of intent. A letter of intent may be presented by one party to another party and subsequently negotiated before execution (or signature). If carefully negotiated, an LOI may serve to protect both parties to a transaction. Send a letter of intent to indicate your intention on a particular matter. As is the case with all letters, the style and wording you use in a letter depends on the specific circumstances. You should write a letter of intent when an employer requests one in a job listing. This letter is to be sent or posted in addition to your resume and other required application materials. A letter of intent can include provisions that are both binding and non-binding. The ways in which a letter of intent can be binding vary. Some of the least binding LOIs essentially contain a contractual agreement to treat the LOI as non-binding. Some more binding LOIs can include the rules of negotiation of a contract as a binding agreement. Letter of Intent Template. These types of letters can be used in a variety of situations including business negotiations, to signal the intent to purchase real estate or by recipients of scholarships or college admissions...Letter of Intent.
